- 1. Minutes of 6 December 2019 Meeting (MOS/SSC/2018/22)
 - Approved.
- 2. Executive Secretary presented an update of Work Programme implementation to-date:
 - 1.1. Signatories
 - **Bermuda Meeting 13-15 March** There have been positive responses from most Signatory government representatives and other supporting governments, including the governments of Cuba and South Africa, about attending the meeting in Bermuda.
 - 1.2. Commission
 - The third day of the meeting in Bermuda (March 15th) will be the 4th Joint Meeting of the Commission and Signatory Governments. Commissioners unanimously agreed that this should be a closed session to discuss the Work Programme.
 - 1.3. Secretariat

The **Executive Secretary** was pleased to report that **Ms Tess Mackey**, formerly the Marine Research Fellow, has been appointed as Programme Manager for the Secretariat – a position she will hold through The Ocean Foundation.

- 1.4. Collaborating Partners
 - Nothing to report.
- 1.5. Fisheries
 - Dr Laurie Kell and Brian Luckhurst are conducting an ecosystem-based fisheries management assessment of the Sargasso Sea using a "Driver-Pressure-State-Impact-Response (DPSIR)" approach. Dr Kell and Dr Luckhurst presented a paper, entitled "Extending the Indicator-Based Ecosystem Report Card to the Whole Ecosystem; A Preliminary Example Based on the Sargasso Sea" at the ICCAT Ecosystem Sub-Committee in June 2018, and will also be giving a presentation at the upcoming SSC meeting in Bermuda.
- 1.6. Sea Bed
 - Kristina Gjerde previously drafted comments on the draft ISA mining regulations, which were circulated to the Commission for feedback and submitted to the ISA Secretariat.
 - The next ISA meeting will be held from 25 February to 1 March at the ISA Headquarters in Jamaica. Dr Philomene Verlaan, who has previously represented the Commission as an observer delegation, is unable to attend.
- 1.7. Migratory Species
 - The Secretariat is working with CMS and the World Maritime Institute to organize a negotiating meeting in Malmo, Sweden from 25-26 June 2019. This meeting will begin negotiations for a CMS instrument for European eel, based on the mandate from the Second Range States workshop in 2018. Professor Chris Wold has drafted a paper exploring options for a CMS instrument, which the Executive Secretary will circulate to the Commission once it has been reviewed.
- 1.8. Finance and Fundraising Report
 - Dr David Vousden was commissioned to develop a Project Proposal for the Global Environment Facility, which was reviewed by the GEF International Waters team in November. The Executive Secretary will send a background presentation to the Commissioners for more details about Large Marine Ecosystem projects.
 - The Commission also received approximately 90K CAD from Fisheries and Oceans Canada to fund the Next Steps to Strengthen Stewardship of the Sargasso Sea meeting in Bermuda.

- **Commissioner Moore** assisted the Commission in proposing to the Donner Foundation that it invite the Commission to apply for \$100K for general support. The Secretariat's application was approved by the Donner Foundation in October.
- Former Deputy Executive Secretary, Kate Morrison, has joined The Ocean Foundation as their new Director of Strategic Partnerships and will be collaborating with the Commission in her new capacity.
- 1.9. Mapping and Monitoring
 - **Commissioner Causey** offered to assist with the NASA COVERAGE project, if appropriate, the **Executive Secretary** will follow up.
- 1.10 Communications
 - The Secretariat Programme Manager, **Ms Tess Mackey**, reported that the next issue of the newsletter will be released in early March to celebrate the 5th anniversary of the Hamilton Declaration.
 - Sargasso Sea Ambassador JP Rouja has created a page on the National Geographic Open Explorer to highlight his photography on the Sargasso Sea. (<u>https://openexplorer.nationalgeographic.com/expedition/nonsuchexpeditionss</u> <u>argassosea/</u>).
 - Collaborating Partner Andrew Stevenson has created a film "The Secret Lives of Humpbacks", which the Commission helped to sponsor. The premiere of the film will be in Bermuda on 20 February.
