Key steps in the Project Process

- Sept 2018 DV hired to draft a concept Note for Medium Size project for \$1 million through UNDP
- Dec 2018 Draft Concept note sent to GEF Sec for comment – Supported by GEF Sec but they suggested to make it a full size project for \$ 3.5 million.
- March 2019 Revised Concept Note discussed at Bermuda Signatories Meeting, followed by review by signatory governments and Commission. DV revised in light of comments
- April 2019 Common Oceans meeting in Rome –
 discussed possible content of the FAO Program. SS
 Project put on the table well received. But FAO
 program was behind schedule



- July 2019, Bahamas Meeting. Commission, Signatories, UNDP and partners.
- Planned to submit to November 2019 GEF Council
- FAO has outstanding Project Evaluations submission delayed until complete – June 2020
- Jan 2020, DF and AH went to FAO in Rome to negotiate inclusion of project in the FAO Program. Agreed but as \$3million of a \$30m program.
- April 2020 FAO incorporated the submission as a Child Project and submitted documentation to GEF
- May UNDP selected IOC as Executing Agency
- June 2020 Approved by GEF Council with PPG of \$100k – 12 month to produce final Project Document (ProDoc)




